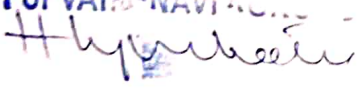

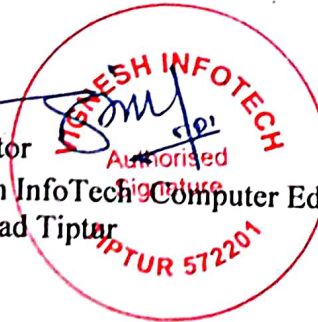

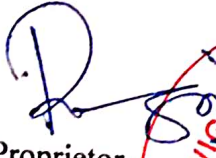

AND WHEREAS the Second party, who is running a educational institution providing the facility to poor students including appropriate premises to set-up a library for the benefit of the students studying therein, have approached the First party with a request to set up one such Free Public Library in their institution, for which the Second party had agreed to do so.

AND WHEREAS both the parties have mutually agreed to reduce the terms and conditions of this MOU in writing;

NOW THIS MEMORANDUM OF UNDERSTANDING BETWEEN THE PARTIES WITNESSETH AS FOLLOWS:-

1. In consideration of the above, the First party had provided the books and other materials required to set-up a library to the Second party on this day as per Annexure – I to this agreement at free of cost. The Second party hereby admits and acknowledges the receipt of the same.
2. The Second party hereby agrees to set-up a library in its educational institution premises at the earliest for the benefit of its students, which shall not be more than 30 days from today and inform the First party about setting-up of the library in writing with documentary evidence, such as Photographs and Video clippings.
3. The Second party hereby agrees that it shall allow the qualified staff/ volunteers/associates/collaborators of 'the TRUST' including the First party to visit the facility to evaluate the needs and recommend suitable equipment, infrastructure, etc., to make more useful of the library to the needy.
4. The Second party shall extend all reasonable support to establish a fully functional library, easily accessible to the students including their families, staff and library volunteers of the local non-profit(s).
5. The Second party shall ensure its active and ongoing operations benefit the students and others, who shall use the library as they see fit in empowering them with knowledge connectivity.

The Second party shall assure and undertake that they shall not sell the books donated for the Library under any circumstances without written consent from the First party and shall be strictly used only for the designated purposes to benefit the students including teachers, their families, staff and library volunteers of the local non-profit(s) and not for any commercial purpose and liable to be maintained in good condition. Further, the Second party shall display the board provided by the First party in a place visible to all visitors to the library.
